Initiating the agenda items Dr. Das thanked all the members for their valuable contribution and participation towards attainment of Excellence and Quality in academic and administrative matters of the University.

The member-secretary appraised the house about the action taken on the matters discussed in last IQAC meeting on two of the issues which are also the agenda items for this meeting:

- 1. Discussion on the feedback given by NAAC peer team in the last peer team visit.
- 2. Finalization of new concurrent academic audit formats.

On Agenda Item 1, the members were shown the observations given by NAAC peer team during previous visits in 2008 and 2013 respectively. The status as on date on the gray areas was also informed to members. Following actionable points came out through discussions:

- ➤ Alumni Association of UPES to be registered as a society and Ms. Alka Madhan to be suitably advised.
- > HR Dept. to conduct a spot survey among the Faculty to judge their willingness to stay on campus if residential facilities are provided.
- > DSA to create and maintain the record of number of students taking part in various sports activities.
- > Action taken on the findings of Academic Audit Reports to be recorded and filed.
- > UPES to engage external experts to audit the Question Papers and the Answer sheet evaluation within the current and the next semester.
- ➤ Gender ratio among the student population for the last 3 years to be prepared and tabled in the next IQAC meeting.
- > IQAC has recommended maintaining question banks with each faculty members and preferably with the UPES library.
- Digitization of the library books must start immediately.
- > Departments to keep records of all Parent Teacher Meetings in the file and available of request.

- > It was also unanimously agreed as under -
 - ✓ The each Assessment Criterion of NAAC assessment will be monitored by dedicated teams
 - ✓ Seven teams will be formed for seven Assessment Criteria.
 - ✓ The Deans/Directors and VP(AA) will decide on the team at the earliest.

On Agenda item 2:

Formats of Concurrent Academic Audit and Student Feedback were discussed. The simplified formats were accepted for implementation from the semester starting January 2017.
