Points of Discussion

- Mr. S. Raghavan Director, IQAC presented the following points to the committee:
 - 1. Academic Administrative audit.
 - The committee was apprised of the successful conduct of Academic and Administrative Audit for eight schools and 21 non-academic functions respectively during the months of April to July 2022. 15 external academicians and corporate personnel were invited as the auditors for the 8 schools.
 - The audit focused on both accreditation requirements and quality aspects, and audit manual as well as audit reports were created for the respective schools.
 - Raghavan shared the scoring metrics on which the schools had been evaluated with 1 being not meeting requirements, 2 meeting requirements and needing major changes, 3 requiring minor changes, 4- meeting requirements, in 8 criteria. It was found that the schools predominantly scored 2 and 3 in almost all criteria.
 - Academic audit findings were presented by Director, IQAC presentation attached in annexure 1.
 - The drafted Academic Report will be circulated to the respective Deans.
 - 2. Raghavan Director IQAC briefed the committee on the Accreditation and ranking updates:
 - University had successfully ranked 97in Overall, 65 in University, 21 in Law, 41 in Management and 61 in Engineering categories in the NIRF Rankings 2022.
 - Academic Quality Assurance Report (AQAR) AQAR submission to NAAC for the year 2019-20 and 2020-2021 has been completed.
 - NBA accreditation of five MBA programmes, School of Business is in the process.
 Successful submission of NBA pre-qualifier for MBA programmes, the next step being submission of Self Study Report.
 - NBA Compliance Report for the reaccreditation of two Undergraduate programmes from the School of Engineering, accreditation had been submitted and the accreditation panel visit was expected in September 2022.
